INDEPENDENT AUDITOR'S REPORT

Pursuant To the agreement ("Agreement") on 15 August 2025 made between the Assistant Head of Create Hong Kong (the "Government") and Hong Kong Film Art Alliance Limited (the "Company"), we have performed a reasonable assurance engagement to report on whether the Company has complied with, in all material respect, the requirements set by the Government for the approved project proposal on page 3 (the "Project Account"), and all the terms and conditions of Film Development Fund, as specified in the agreement.

Responsibilities of Directors of the Financial Statements

The government required the Company to keep proper books of accounts of all receipts and payment of the Company in respect of the Project and to comply with the requirements and all the terms and conditions of Fund Development Fund Funding, as specified in the Agreement.

We planned and performed our reasonable assurance engagement so as to obtain all the information and explanations which we considered necessary in order to provide us with sufficient evidence to give our conclusion as to whether the Association has complied with, in all material respects, the requirements set by the Government, and all the terms and conditions of Film Development Fund, as specified in the Agreement.
